SCHOLARSHIP INFORMATION

The Australian Women Pilots' Association, through the sponsorship of Advanced Flight Theory, is pleased to make this scholarship available. To be awarded for a complete course for ATPL Helicopter and Aeroplane Theory, the scholarship is to assist two female pilots to meet the costs of an Air Transport Pilot Licence theory course.

Scholarship 1: Helicopter ATPL has the following subjects completed full time at Sunshine Coast Airport; Aerodynamics, Navigation and Aircraft Systems. Distance education subjects are; Performance and Loading, Flight Planning, Meteorology, Human Factors, Air Law.

Scholarship 2: Aeroplane ATPL has the following subjects completed full time at Sunshine Coast Airport; Aerodynamics, Navigation, Performance and Loading, Flight Planning and Aircraft Systems. Distance education subjects are, Meteorology, Human Factors, Air Law

The scholarship winners will be announced at the Awards and Presentation dinner on Saturday 3rd of May 2024 in Busselton, WA.

Scholarship Criteria

1. Financial member of AWPA as at January 1 2025
2. Must be an Australian citizen, a permanent resident or reside in Australia
3. Australian Commercial Pilot Licence or completion of Commercial Pilot Licence subjects

Supporting Documentation

In compiling your application, you will be required to:

- complete the relevant application form
- write a short essay on why you deserve to win this scholarship
- Provide evidence of your Australian Citizenship, Permanent Residency or Australian residential address
- Provide evidence of your CPL or CPL theory exams completed

Scholarship Conditions

1. The scholarship funds will be available from 3rd of May 2025 to 30th of June 2026. However, eligible expenses incurred from the time that applications close may be claimed as well. So the effective period of the scholarship is from 1st of February 2025 through to 30th of June 2026.
2. The scholarship is personal to the recipient and cannot be transferred to another person, or be cashed in, in the event of inability to continue studying for any reason.
3. The scholarship will pay up to \$7,750, for ATPL Aeroplane or up to \$6,307, for ATPL helicopter theory to the recipient. The recipient will be enrolled into the course by AFT for a suitable course within the scholarship period.
4. The scholarship organisers:
 - a. will not extend the value of the scholarship to account for any changes in costs of ATPL courses;
 - b. will make a decision as to the selection of the recipient that is final;
 - c. reserve the right not to present the scholarship if in the judgement of the selection panel none of the applicants are deemed suitable.
5. Accommodation, ASPEQ/CASA examination fees, and other ancillary costs are not covered in this scholarship.
