



NSW 2000 Edna Grose Scholarship 2025

SCHOLARSHIP INFORMATION

The intended use of the scholarship could include multi-engine class rating, design feature endorsement, flight review, PPL training, CPL training, private instrument rating (PIR), a flight activity endorsement, cross country gliding rating, aircraft type rating. It is intended that the scholarship be used for the attainment of one qualification and only for the intended purpose nominated on the application form. This list is not exhaustive and is for guidance only.

Note: This scholarship is not intended to be used to obtain an Instrument Rating (IR), Flight Instructor Rating (FI) or Night Visual Flight Rules rating (NVFR).

SCHOLARSHIP CRITERIA:

This scholarship is open to all eligible members of the Australian Women Pilots' Association and may be used for fixed wing, rotary wing, gliding or balloon flight.

1. Membership of AWPA – twelve months' minimum.
2. Hold a current Australian Medical (as applicable).
3. Hold a Recreational Pilot Licence (RPL) or higher or equivalent for gliding or ballooning.
4. Hold the appropriate licence or rating to undertake the proposed flight training.
5. For PPL, CPL or PIR, passes in the appropriate theory examinations must be completed by the nominated application closing date of 31 January 2024 (evidence to be provided).
6. Must be an Australian Citizen, a permanent resident or reside in Australia

SUPPORTING DOCUMENTATION:

All scholarship applications must include the following items:

1. Essay, not longer than 500 words, on why you wish to undertake the nominated flying
2. A copy of licence or logbook entry indicating highest licence or rating held
3. A copy of the results for theory examinations (as applicable)
4. A cost estimate from the proposed flying school or organisation providing the training.

5. Evidence of Australian Citizenship, Permanent Residence or Australian residential address.

SCHOLARSHIP CONDITIONS:

All recipients of scholarships must have completed their training and have their licence endorsed within twelve months of receiving the award. This can be reviewed in extenuating circumstances, upon application. The scholarship monies will be paid to the flying training organisation of the recipient's choice on a dollar-for-dollar basis up to \$2500. Proof of payment (statements and receipts) must be supplied.

Scholarship funds may either be paid directly to a Part 141 or 142 Flight Training Operator or the applicant may have scholarship funds reimbursed to them if proof of payment to a Part 141 or 142 Flight Training Operator is provided. Note: Gliding Clubs are not subject to the Part 141 or Part 142 requirement and the applicant can be reimbursed following proof of payment to a Gliding Club

The successful applicant will be announced at the Awards and Presentation Dinner on Saturday 3rd of May 2025 at Busselton WA.
